

Diocese of Pittsburgh Policy: Safe Environments for Children

Purpose:

To take reasonable measures to assure that Church Personnel (employees and volunteers) comply with all the required certifications and background checks to permit the necessary assessment of suitability for contact with children with the purpose of providing a safe environment for said children.

Applicability:

All Church personnel (employees and volunteers) with their equivalent as named below under Employee and Volunteer Capacities are required to obtain certain certifications and background checks as set forth below under Certifications and Background Checks.

The (**) positions are also required to complete Step 8 The Mandated Reporting Training in addition to Steps 1 – 7 per the Diocesan and Pennsylvania State Volunteering requirements as it applies that these positions may have possible direct contact with children. All Clergy, all school employees, all school volunteers and all other employees and volunteers who are responsible for the welfare of a child or have regular contact with children are also included.

- 5) Reporting Child Abuse and the Child Protective Services Laws of Pennsylvania Acknowledgment (completed during the data base process).
- 6) Protecting God's Children Workshop (click on Online or Live Training Tab for links).
- 7) FBI Criminal History Report (Fingerprinting) or the Completion of the Diocese FBI Disclosure Statement Application for Volunteers form if he or she has been a Pennsylvania Resident for a consecutive 10 years and have not been convicted of the Offenses listed on the document. - 8) **Mandated Reporter Training Course (click on Online or Live Training Tab for links).
